Absorb the remaining liquid and any small spills with clay granules, sand, or other absorbent material and sweep into a waste container. Minimise run-off into drains or waterways.
Fire	Vapours may be toxic. Self-contained breathing apparatus required, chemical suit recommended. Addition of water may cause excessive foaming. Do not allow contaminated run-off to enter drains or waterways.
First Aid	Remove victim to fresh air. Apply resuscitation if victim is not breathing.
