GENERAL INFORMATION:

Advance Gold is for use in kiwifruit var. Gold3. It is not intended to be used on any other varieties. When applied with Advance Gold Activator it will usually:

- Increase budbreak
- Make timing of budbreak more uniform
- Condense flowering
- Increase flower numbers
- Reduce lateral flowers

Advance Gold is intended as a management tool to assist with optimum fruit loading and sizing. Other management practices such as cane density and fruit thinning will need to be optimised. The effect can be influenced by winter chill.

DIRECTIONS FOR USE

Always apply to dormant kiwifruit no more than once per year. Rates are for dilute application. DO NOT use concentrate application methods. Never apply more than 27 litres of Advance Gold/Ha.

APPLICATION TIMING: To obtain the best possible result apply 35 days before expected natural bud break. Bud break is predicted by local best practice taking into account winter chill and local knowledge. Applications made earlier or later than 35 days before natural bud break may be less effective. Applications made more than seven days earlier or seven days later than 35 days before expected natural bud break will be less effective.

MIXING: Firstly pour the correct volume of Advance Gold into the partly filled tank with agitation running until completely mixed. Then pour the correct volume of Advance Gold Activator slowly into the tank and while agitating add the remainder of the water. Maintain agitation during spraying and any stoppages. Only mix sufficient spray for immediate use and avoid storing.

DRIFT CONTROL: Spray drift must be prevented as it may damage non-target plants. Use of specialist equipment such as air inclusion nozzles to reduce drift is advised. DO NOT use tank mixed drift control agents.

ADJUVANTS: The Advance Gold plus Advance Gold Activator mixture does not require any further adjuvant to enhance efficacy.

COMPATIBILITY: Do not tank mix any other products with the Advance Gold plus Advance Gold Activator mixture.

APPLICATION: Only use conventional high volume ground based sprayers that are accurately calibrated for the purpose. Use 700 to 900 litres of water per hectare to ensure complete and even coverage of all dormant cane surfaces without run-off. Do not use concentrate spraying techniques. Do not apply the mixture into or onto water.

RAINFALL: Results may be reduced if rainfall or irrigation occurs within six hours of spraying.

WORKER RE-ENTRY: Do not enter sprayed areas until spray has completely dried unless appropriate personal protective equipment is worn.

WITHHOLDING PERIOD: Not required when used as directed. MRL exempt.
